Purpose and Conditions of the Subsidy Scheme

This aid scheme is intended to promote the participation of high-level junior members in tournaments that they need to play in order to be included in their respective regional and national rankings, provided that the Club does not organize travel for the players as a group.

It is understood that, due to their age, they are capable of traveling alone; therefore, for such events, the Club will not arrange for them to be accompanied by adults, although it will seek to coordinate support from the RFGA coach attending the competition.

The aid will be granted directly to players wishing to participate in ranking events under the following conditions:

- Subsidies may be requested and accessed by those member players who, in the Club's opinion, have a real chance of achieving good positions in their respective rankings. Specifically, players ranked among the top 5 in Andalusia (Infantile), top 10 (Cadet), or top 15 (Boy/Girl/Junior) categories, and who:
 - for territorial ranking events, have a national handicap of first category, i.e., equal to or less than 4.4,
 - for national ranking events, are “scratch” players, i.e., have a handicap equal to or less than 1.4.

(As well as other players who, exceptionally and without meeting these requirements, are selected by the School Committee.)

- Only players who actively participate in the Club's sports activities will be eligible for aid. This means that they must not have failed to participate in competitions for which they were required, such as team championships or similar events.
- Players who have outstanding debts with the Club—whether due to unpaid fees or failure to reimburse subsidies received from the RFGA or RFEG—will not be eligible for aid.

- Players traveling to a specific event under the auspices of the RFGA or RFEG, or representing another club, will not be eligible to receive a subsidy from the Club for that event.
- Only those players who also accept the conditions imposed by the RFGA for the possible granting of its subsidies may receive a subsidy from the Club for a specific event. For example, if the RFGA organizes a group expedition and only grants subsidies to those participating in it, then only those players participating in the RFGA expedition may receive the Club's subsidy for that event.
- The subsidy must be requested prior to the competition and collected within a maximum of three months after the event concludes.
- It is mandatory for the recipient to wear the Federation uniform during the competition, if available, or otherwise the RCG Guadalmina School uniform. If any player loses a potential subsidy from the Federation for failing to comply with this requirement, they must reimburse the Club for the amount received.

Club-Organized Trips

In instances where the Club organizes and covers the cost of a trip, no subsidy will be granted.

IMPORTANT NOTE:

By accepting any subsidy or financial aid, or by participating in a Club-organized trip, the player agrees to the terms outlined in this information notice and, specifically, undertakes to reimburse the Club for the amount received as aid in the event that they receive a subsidy from the RFGA or RFEG for the same event.

If a player receives a subsidy from the RFGA or RFEG for a specific event, they must reimburse the Club the amount of that subsidy, up to a maximum of the amount received from the Club for that same event. That is, for example:

- If the Club provides €260 and the Federation provides €150, the player shall reimburse €150 to the Club.
- If the Club provides €260 and the Federation provides €500, the player shall reimburse €260 to the Club and retain the remaining €240.
