

SOCIAL ANNUAL SURCRIPTION FOR DIRECT MEMBER'S RELATIVES RULES AND APLICATIONS

TO WHOM IT APPLIES

Applicable to direct relatives of first degree of affinity of active Members who are up to date with the payment of their membership fees.

- Wife / Spouse (of an active member)
- Children over 25

ACTIVITIES & SERVICES AVAILABLE

The activities contemplated include, among others, the following

- Unlimited use of the swimming pool
- Unlimited use of the gym, with the possibility of making a reservation.
- Use of the paddle tennis court, with the possibility of booking and including guests in your reservations by paying the corresponding fee in each case.
- Use of the tennis court, with the possibility of booking one and including guests in your reservations by paying the corresponding fee in each case.
- Use of the croquet court, with the possibility of booking one and including guests in your reservations by paying the corresponding fee in each case.
- Use of the bridge room by paying the membership fee
- Access to the members' area.

ADMISSION SYSTEM

Subscribers admitted by the Board of Directors, will be conferred the title of annual SOCIAL subscriber.

The renewal of the annual subscription may be understood by tacit renewal, for equal periods of one year, with no other procedure being necessary to terminate the validity of the same, than the written denunciation by the Board of Directors, said denunciation not admitting any appeal.

ADMISSION PROCEDURE

To be accepted by the Board of Directors, aspiring subscribers shall:

- Submit an application for membership, signed by the proposing Member, with whom
 he/she maintains the degree of kinship or affinity, addressed to the Board of Directors,
 which must be delivered to the Club's registered office.
- Applications will be studied by requiring the proposer to provide documents proving the relationship or affinity.
- Once the documentation has been studied, the Board of Directors will take whatever steps it deems necessary, in order to decide whether or not to admit the applications, within a period of no more than 7 days.
- The Board of Directors shall inform the applicant whether his application has been accepted or rejected, within a maximum of 12 days from the date of the application.
- The rejection of an application must always be justified and shall be based on objective reasons, which shall be made known to the applicant, who shall be given a period of fifteen working days to present his or her arguments.
- The Board of Directors shall take a final decision within five days of receipt of the letter of allegations, and this decision shall be final.
- Applicants whose applications have been approved must pay the fee established by the Club in this respect. If after five (5) working days have passed since the applicant should have paid the fee, he/she has not done so, it will be understood that he/she has waived the right to be a Season Ticket Holder and his/her application will be cancelled.

ANNUAL FEE

For 2022 is established $420 \in$ to be paid in a single payment. Only the first year, the same criteria as the initial fee may be applied, with discounts of 50% or 75% depending if the subscriber joins after July 1^{st} or October 1^{st} respectively

DURATION OF THE SUBSCRIPTION

It will have a duration of one calendar year, starting on 1 January, with the exceptions described in the previous section, until 31 December, regardless of the month in which it is incorporated,

HOW THEY SUSCRIBERS WILL BE HANDELED BY THE RESERVATION PROGRAMME

The reservation system will consider them as subscribers, with a different numbering than the active Members, e.g. AB0001, AB0002 ... etc, linked to the proposing Member, and within their file, even for direct debit payment, if necessary.

These subscribers will be registered in the system with the limitations described above.

If they are included in a golf booking, guest rate will be applied, taking into consideration their age.
